NOTIFICATION **Ph.D ENTRANCE EXAMINATION 2024-25**

Applications are invited from Indian Nationals for Ph.D Entrance Examination of 2024-25 of the University of Mysore for available research vacancy positions in various disciplines. List of subjects are available on the website of the University of Mysore. It should be noted that, appearing and completion of the entrance examination implies only the eligibility for consideration for admission to Ph.D Degree program of the University. It does not guarantee admission to any Ph.D Degree Program of the University. Details are provided in the Ph.D Regulations-2017. **(See the website <https://uni-mysore.ac.in>)**

Interested and eligible candidates may apply online. The candidates should check their eligibility exemptions (Section-B) before applying online (**<https://uni-mysore.ac.in>**). The application form will be available on the website from **04/10/2024** to **24/10/2024**.

The dates of Entrance Examination will be notified on University website. All the examinations will be conducted at Mysuru centre only. The details including the syllabus for the Entrance Examination are available in online.

A. Conditions for Eligibility:

- 1) Candidates should have secured at least 55% of aggregate marks in their respective PG Programs. A relaxation of 5% marks or its equivalent grade may be allowed for those belonging to SC/ST/Cat-1/OBC (non-creamy layer), Differently-Abled, Economically Weaker Section (EWS) and other categories of candidates as per the decision of the UGC from time to time.
- 2) The candidates should satisfy the other eligibility conditions as stipulated in the regulations.
- 3) Candidates who are currently in their Final Semester of **Master's Degree** may also apply.

B. Exemptions:

Candidates satisfying the following condition are exempted from the Entrance Examination as per Ph.D Regulation 2017, Section 5.9.

- 1) Candidates who have qualified JRF fellowships/Lectureship through UGC/CSIR-NET/DBT-JRF/ICMR-JRF/ICAR/SLET (KSET) Gate. (For M.Phil-Ref UGC-2016 Notification-3 (3.2) followed).

Note:

RGNF/MANF/Project fellows are not exempted from Ph.D Entrance Examination.

C. Syllabus and questions paper pattern for Ph.D Entrance Examination:

The prescribed syllabus for the Entrance examination is available at www.uni-mysore.ac.in. The question paper for all the subjects contains 2 parts.

- Part-A: 50 objective type questions of one Mark each.
 - Part-B: Essay Type/short answers questions for 50 Marks.
- Duration of the Examination will be 3 (three) hours. Both Parts are Compulsory.

D. Procedure to apply online:

Candidates should fill the application online and make Payment of the application. All the supporting documents should be uploaded online.

E. Application Fee:


- a) SC, ST, Cat-1 candidates with annual income less than **Rs.2.5 lakhs** per annum **Rs.1,250/- per subject**. (For students who produce Caste and Income Certificates issued by the Concerned Authority of Karnataka only).
- b) SC, ST, Cat-1 candidates with annual income more than **Rs.2.5 lakhs** per annum **Rs.2,500/- per subject**.
- a) All others **Rs.2,500/- per subject**.

F. General Instructions:

1. There is no upper age limit to apply for the Ph.D Entrance examination.
2. No Entrance exam for Foreign Nationals.
